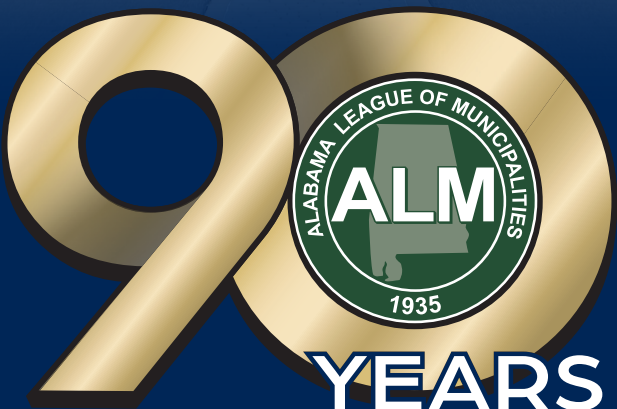

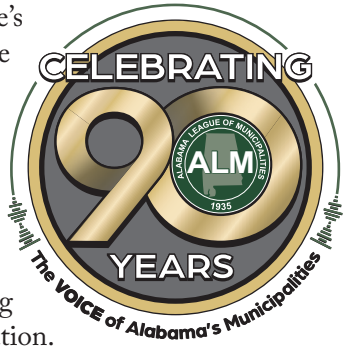

## Coming to Montgomery

When visiting Montgomery, schedule meetings with your legislator in advance. Legislators' offices are located in the Alabama State House at 11 South Union Street. House members' offices are on the fourth through sixth floors, while the Senate offices are on the seventh floor. Parking is available at the League's building at 535 Adams Avenue, with limited metered parking nearby. Always remain courteous, professional and respectful, as you represent your municipality.

## Meeting Your Legislator

Schedule meetings in advance and prepare a clear and concise message supported by facts or data. Use the meeting to discuss how the proposed legislation affects your municipality and its citizens. Flexibility is important, as legislators' schedules may shift during sessions. After the meeting, follow up with a thank-you note or email to express your appreciation for their time and effort.

## Calling Your Legislator

Prepare concise talking points before calling, referencing the bill number (e.g., HB ## or SB ##). Begin by introducing yourself as a constituent or local official and share insights or personal stories that support your stance. Be polite when speaking with either the legislator or their assistant, as assistants are often a key gateway to direct communication. Provide your contact information for any follow-up inquiries and conclude with a thank-you to ensure a courteous and professional impression.

## Writing Your Legislator

When writing, address legislators formally, including their title, name and room number at the Alabama State House. Clearly state your position (support/oppose), referencing the bill number and sponsor. Explain briefly why the issue matters, emphasizing its impact on your community with relevant key points or data. Include your contact information and attach a business card for follow-up purposes. After sending your letter, confirm receipt with a follow-up phone call. Always express gratitude for their time and consideration, regardless of their position.
