

Opening Session Address of the 2007 League Convention

Municipal Officials Can't Afford to be Passive Regarding Legislative Issues

Mayor Penhale, Mayor Spencer, Councilmember McCollum, Treasurer Ivey, Ladies and Gentlemen, I am honored to stand before you this morning as we formally open our 2007 annual convention. It has been a privilege to have served as your president this past year. I appreciate the opportunities you have given me and I thank you for your confidence and support. But most of all, I thank you for your friendship.

Mayor Spencer, as usual the hospitality of the Rocket City has been exceptional. I want to personally thank you, the Huntsville City Council and your staff, for welcoming us with open arms. Saturday's dinner was superb and I think everyone enjoyed the festivities planned by the City.

I also want to thank Mayor Sonny Penhale of Helena, who has represented us well as our League vice president this past year. Sonny is a long-serving, dedicated mayor. The citizens of Helena are fortunate to have such a tireless leader.

Treasurer Ivey, we certainly thank you for being with us this morning. Your schedule is no doubt quite busy this time of year. Thank you, also, to Councilmember McCollum, who is here not only representing the City of Madison, but all municipal officials as the First Vice President for the National League of Cities. Cynthia is the first elected official from Alabama to be in line for the presidency of NLC. This is a tremendous honor, not only for Cynthia but for all of Alabama. The gavel will be passed to her in November during NLC's annual Congress of Cities. I've known Cynthia for a number of years, having served with her on the League's Executive Committee, and I know you agree with me when I say we couldn't ask for a better representative at the national level. I've no doubt she'll continue to make us proud! Please join me in honoring Cynthia with a round of applause for a job well done!



This has truly been a rewarding year. It's gone by so quickly, I can hardly believe my term is over. It has been my honor to represent municipalities in Alabama as I have traveled with League staff to meetings in Washington Reno and Little Rock. My tenure as president of the League has deepened my respect for Perry Roquemore and his entire staff. Our League is highly respected by the National League of Cities for its operations in Alabama and its ability to engage its membership on state and national issues affecting local governments. We are fortunate to have an organization representing our interests that is so well managed and professionally staffed.

In fact, the League staff is constantly looking for ways to strengthen our municipalities and to enhance information exchange between our cities and towns. For example, this past winter, the League implemented a Municipal Achievement Awards program designed to recognize successful, impressive municipal improvement programs. Minutes of the General Business Session

Alabama League of Municipalities, Huntsville, Alabama April 24, 2007

The General Business Session of the Convention of the Alabama League of Municipalities was called to order promptly at 2 p.m., April 24, 2007, by President Carroll L. Watson, Mayor of Lincoln, at the Embassy Suites Hotel in Huntsville, Alabama. Mayor Watson thanked everyone for their attendance at the annual business session and for their efforts on behalf of the League during the past year. He also thanked the membership for giving him the opportunity of serving as president during the past year.

The president then called upon Perry C. Roquemore, Jr., Executive Director of the Alabama League of Municipalities, for his annual report. Mr. Roquemore expressed his appreciation for the support of the officers, staff and membership during the past year. He stated that the League membership was now at 451 cities and towns and that League finances would be adequate for fiscal year 2006-2007. He also discussed the current legislative session and numerous League services and programs. A copy of his report is on page 17 of this publication.

President Watson then called on Mayor Leon Smith of Oxford, President of the Municipal Workers' Compensation Fund, Inc., for an annual report. Mayor Bobby Payne of Tallassee, Chair of the Alabama Municipal Insurance Corporation (AMIC), was then called on to make AMIC's annual report. Mayor Roy Dobbs of Berry, Chair of the Alabama Municipal Funding Corporation (AMFund) was called upon to make the AMFund annual report.

The President then called upon Mayor Bob Bunting of Ozark, chairman of the Resolutions Committee, for the committee's report. Bunting reported that the Resolutions Committee had met on Saturday, April 21, and had recommended that the League's *Policies and Goals for 2007* be adopted with the following amendments:

- 1. Amend Policy Position F-3.24 by deleting the word "urges" in line 1 and by substituting in lieu thereof the following: "strongly urges the Alabama Legislature to mandate"
 - 2. That Policy Position F-3.25 be deleted.
- 3. That Policy Position **F-5.16** be amended to read as follows: "That the League propose legislation to authorize an alternative method for publishing license, zoning and planning ordinances by means of a synopsis published in the newspaper."
- 4. That Policy Position **P-8.3** be amended by striking the letters "CJIS" on the last line and by substituting in lieu thereof the letters "ACJIC".

- 5. That Policy Position **H-1.1(e)** be amended by inserting after the word "legislation" in line 1 the word "**to**".
- 6. That Policy Position **H-3.5(a)** be amended on line 3 by deleting the word "sufficient" and by inserting in lieu thereof the word "increased".

Council Member Charlie Johnson of Luverne moved that the change to Policy Position **H-3.5(a)** changing the word "sufficient" to "increased" be rejected and that the original language using the word "sufficient" be retained. Mayor Johnny Ford of Tuskegee seconded the motion. The motion passed.

Council Member Karyl J. Rice of Pelham moved that Policy Position **F-3.25** relating to property reappraisals be restored. Council Member Elaine Junkins of Guin seconded the motion. The motion was defeated and Policy Position **F-3.25** will remain deleted.

Mayor Bunting moved adoption of the *Policies and Goals for 2007*, as amended, and the motion was seconded by Mayor Johnny Ford of Tuskegee. The motion carried.

Mayor Bunting then presented the resolutions for adoption. He pointed out that members were given summaries of 52 resolutions recommended by the Resolutions Committee. Council Member Edward H. Carroll, Sr., of Orange Beach moved adoption of Resolutions 1 through 46, 48, 49 and 50. The motion was seconded by Council Member Ed Scott of Adamsville. The motion was adopted.

Mayor Bunting moved adoption of Resolution No. 47 memorializing former State Senator Charles Langford. The motion, which was seconded by Council Member Ed Scott of Adamsville, passed unanimously.

Mayor Bunting moved adoption of Resolution No. 51 memorializing those active and former officials who passed away since the last convention. Mayor James Perkins of Selma seconded the motion. The motion passed unanimously.

Mayor Bunting moved adoption of Resolution No. 52 honoring Mayor Carroll L. Watson of Lincoln for his service as President of the League. The motion, which was seconded by Council Member Edward H. Carroll, Sr. of Orange Beach, passed unanimously.

The President then called upon Mayor Bobby Payne of Tallassee to present the report of the Nominating Committee. Mayor Payne said the Nominating Committee had a tough assignment choosing officers for the next year from an abundance of very qualified candidates. He reported the




Address – President's Banquet 2007 League Convention

Director's Report League Convention, April 24, 2007

It's my pleasure to bring you up-to-date on the operations of your League for the past year. Since we met in Mobile last year, your League officers and staff have been busy implementing new programs and trying to protect the interests of Alabama municipalities at both the national and state levels.

League Committees

The Executive Committee, presided over by our able President Lew Watson and Vice President Sonny Penhale, met three times during the past year and dealt with numerous issues on each occasion. Our five policy committees met on separate days at League Headquarters to hear resource advisors speak on issues of importance to the committee. Following the presentations, the committee members revised their respective policy statements. The revised policy statement, created through the hard work of these committee members, is ready for your final consideration today. Our Polices and Goals document is very important as it is used to guide your League staff throughout the year and to assist the Committee on State and Federal Legislation when it meets each year to develop the League's legislative package. I want to personally thank our Committee chairs and vice chairs for their leadership and hard work. I also want to thank all the officials who served on our committees this year for their valuable input. Would all of the participants on our committees please stand up so that we can applaud you for your effort? I also would encourage any of you who did not serve on a League committee to let us know if you would like to serve. We would love to have your involvement and ideas.

NLC Activities

The Alabama League of Municipalities continues to be well represented at NLC meetings and activities during the past year. The League had one of the largest state delegations at the National League of Cities Congress of Cities in Reno, Nevada, in December, and at the NLC Congressional-City Conference in Washington, D.C. in March. In December, one of our own, Council Member Cynthia McCollum of Madison, Alabama, was elected First Vice President of NLC and is in line to become President of NLC in November. Mayor James Perkins of Selma was elected to serve a second year on the NLC Board of Directors and Mayor Leon Smith of Oxford and Mayor Ted Jennings of Brewton continue to serve on the NLC Advisory Committee.

Council Member Debbie Quinn of Fairhope has been named Chair of the NLC Energy, Environment and Natural Resources Committee. Mayor Perkins of Selma was named Chair of the NLC CityFutures Panel on Equity and Opportunity and Council Member Janet May of Montgomery was named Chair of the NLC Central Cities Council.

League President Lew Watson of Lincoln serves on the NLC Information Technology and Communications Steering Committee and Council Member Ben Reed of Gadsden serves on the NLC Community and Economic Development Steering Committee.

Alabama has been well represented on the NLC Small Cities Advisory Council for many years by Mayor Billy Joe Driver of Clanton and Mayor Jay Jaxon, Jr. or Eufaula. This year they were joined by Council Members Terry Adams of Midfield, Elaine Lewis and Kevin Walker of Wetumpka. A number of other Alabama officials serve on NLC Policy committees. I ask that all Alabama officials who serve on NLC boards and committees to stand and be recognized.

Membership

The League's membership now stands at 451 municipalities representing over 99% of Alabama's urban population. This is an increase of 8 municipal members since this time last year. Although the number of participating municipalities is very high, we believe there are other small communities in our state that could benefit from League membership. We encourage officials in League member cities and towns to urge their neighbors who are non-members to join the League.

Finances, Property and Equipment

The League's finances for the current 2006-2007 budget year are expected to be adequate to meet the Executive continued next page

Committee's budget that was adopted last July. Last year I reported that we had purchased a lot of equipment, built a secure, temperature-controlled room to house the equipment, and had hired a full time IT person to keep it all running smoothly. This year I can tell you that we have added a second IT person and doubled the size of the room to house our computer infrastructure. We are well on the way to converting a lot of our information into a digital format. This is quite an undertaking when you consider the thousands of documents and records that we maintain. Most of our programs have been updated to run the latest software. We have spent a lot of time and effort to insure that our data is completely and accurately backed up and that the security of our system is top notch.

We have also purchased equipment and have the expertise on staff to develop League-produced videos. Our first production was shown on Sunday afternoon announcing the 2007 Achievement Award winners. I expect our investment in technology to produce significant benefits for our members in the coming months.

We have just completed a project to remodel certain areas in the League Headquarters building and to add new carpet or tile floors in much of the building. We have also opened an Archives Room to display the history of your League for visitors to see.

Let me encourage all municipal officials to drop by your League Headquarters building anytime you are in Montgomery.

League Services

The League is a service organization. In addition to our lobbying efforts and our efforts to assist municipal officials by providing information, advice and training, the League also has several programs in place to save money for our member municipalities. These include the Municipal Workers Compensation Fund, the Alabama Municipal Insurance Corporation, the Municipal Revenue Service program for collecting delinquent insurance license taxes, our computer software programs – the *ALM Library* and *MunicipaLaw on Disc, and* the Alabama Municipal Funding Authority or AMFund, which became operational this year and will be providing an additional financing alternative for our members.

The League continues to endorse several other programs such as the AIG-VALIC deferred compensation program, the City Net long distance telephone program through Delta Com, the Gov Deals online auction service, the Debt Recovery Program, and the Cable Franchise Management Program.

If you need any of these services, I recommend you contact the League or the endorsed providers. Most of them have had displays in our trade show. The League officers

and staff will continue to look at new and innovative programs to assist our member municipalities.

Legislative Program

We had just completed the 2006 Regular Session when we met in Mobile last year. The League Committee on State and Federal Legislation, led by its Chair, Mayor Bob Bunting of Ozark, and its Vice Chair, Council Member Charles Woods of Childersburg, met in November and adopted an ambitious League Legislative Package for the 2007 Regular Session. Today marked the 14th day of the 2007 Regular Session. After today, there are only 16 legislative meeting days left. Due to the dispute between the two sides over Senate rules and committee assignments, nothing of great significance has passed this session. I'm happy to report that most League bills are moving and are in a position to be passed should the parties in the Senate reach a compromise. If a compromise is not reached, then I expect very little to be enacted.

CMO Program

Our Education Program for the Elected Municipal Official, which gives every elected municipal official in Alabama the opportunity to obtain the designation of Certified Municipal Officer (CMO), is completing 12 years. Since the program began, we have had 2783 officials participate in the program, 1406 of whom are active. As of last week, 712 officials have obtained the required 40 credit hours of training for Basic CMO certification and 282 officials have earned their Advanced CMO designation. At this Convention, additional officials will earn their Basic and Advanced CMOs. The names of this year's graduates will be announced at dinner tonight. A ceremony will be held in Montgomery this summer for this year's graduates.

Publications and Information

The Alabama Municipal Journal continues to be one of the country's best municipal publications. The League's Web Page has been significantly improved this year to give members another method of obtaining needed assistance. We are getting a tremendous amount of hits to our site together with many compliments on it. If you haven't had the opportunity, please check out our web site at www.alalm.org. It has quite a few features to assist League members.

This year we established our new Municipal Achievement Awards Program. I feel the first program was highly successful and I urge each of you to submit an entry in this program when we seek applications this fall.

Legal Services

Our Legal Department continues to provide top notch

legal assistance to our members. Last year, approximately 8,000 of your inquiries were fielded by our legal team. In addition to answering your legal questions, they also provide two training workshops annually for city attorneys and are in constant demand to speak at meetings for lawyers and non-lawyers throughout the state. Our legal staff also prepares monthly articles for the web page and the *Alabama Municipal Journal*.

League Staff

League employees are assigned to work in one or more of the followings areas or departments – Legal and Research, Finance, Legislative, Communications, Member Services, CMO, IT, or Insurance. Although I am biased, I am certain that I have the best staff in America. These extremely competent people provide excellent service our members on a daily basis. Please join me in thanking them for a job well done.

Looking Ahead

Our League is recognized as one of the most successful in the country. The reason is simple — the untiring efforts of our membership. Your President and Vice President have

done a super job on your behalf. Your past presidents continue to offer needed advice as we move forward.

The next year will be full of challenges for municipalities. We will have to find ways to deal with rising fuel costs, rising health care and pension costs, and the threat of legislation to eliminate or restrict municipal power to control our own affairs. The League will work hard to improve all of our services and develop new services to meet the challenges facing our cities and towns.

In closing, I want to thank all of our municipal officials who have participated in League activities during the past year. Individuals from large cities and small towns from all parts of Alabama have worked together for the common good of municipal government in Alabama. Alabama municipalities are truly blessed with dedicated officials. Remember, this is your League. Our ability to produce positive results for our members depends upon the involvement and teamwork of our municipal officials. If you know of municipal officials in your area that do not get actively involved in League activities, encourage them to do so. This League is only as strong as its members.





Throughout my years of public service, this year as your League president stands out as one of the most memorable. I've had the opportunity to make new friends, encourage old ones and work to impact legislation benefiting local government.

This week we will hit the midway point of the 2007 Regular Session. Nothing of major significance has been enacted thus far; however, the League is currently monitoring 193 House bills and 117 Senate bills that, if enacted, would effect municipal government. Although most of these bills would provide positive changes in the law, there are always some bills that could seriously effect the administration of municipal government. The League lobbying team has been working diligently to kill or have amendments placed on these bills to address municipal concerns.

The Committee on State and Federal Legislation adopted an ambitious legislative package of bills for the League to pursue. These bills are currently moving through the legislative process. Our lobbyists are working hard to get our bills in position to be passed should a window open later this session.

However, our great lobbying team cannot do the job alone. They need our assistance. What can we do?

First, several times a week make it a point to check the State Legislation section on the League's web page for the latest developments. It's easy to do this. Go to the League web site at www.alalm.org. When you reach the Home Page, look to the right side of the screen and click on the button labeled STATE LEGISLATION. This will take you to the section containing the latest Legislative Bulletin and the latest status of every bill being tracked by the League. Pay particular attention to any calls for contacts.

Second, read the summaries of all of the newly-introduced bills. If one causes you concern, contact the League and your legislators to make them aware of your concerns.

We can't afford to be passive officials when it comes to legislative issues. Follow these two simple instructions and become an active member of the League lobbying team. When the League asks us to contact the Alabama Legislature regarding important issues, please take the time to make those calls to let our senators and representatives know where we stand. It is imperative that we work together because, while it may be easy to brush off one or two mayors with a message, it is *impossible* to ignore 450 mayors and more than 2,000 councilmembers who are united in their efforts to be heard.

I want to take a moment to give you a quick update on the League's newest program—the Alabama Municipal Funding Corporation, or AMFund, which was launched in 2005 to help municipalities obtain funding for projects to benefit their communities. AMFund issues tax-exempt bonds. The proceeds from these bonds fund AMFund, from which individual League members can borrow at low tax-exempt

interest rates to fund almost any municipal equipment or project. AMFund takes advantage of the economies of scale offered through pooled financing, which allows municipalities to share issuance costs to reduce each borrower's costs, and participates in bond issues of sufficient size to enable the borrowers to achieve attractive pricing.

AMFund made its first bond issue in January 2006, loaning over \$17 million to seven municipalities. Since then, AMFund has loaned approximately \$25 million to 14 municipalities.

AMFund is managed by a board of directors composed of municipal elected officials. Mayor Roy Dobbs from Berry chairs this board and Councilmember Charles Woods from Childersburg serves as Vice Chair. The other members of this board are Mayor Jim Byard of Prattville, Mayor Wally Burns of Southside and Mayor Howard Shell from Atmore. We are grateful for their assistance with and sound management of AMFund.

The League and AMFund look forward to working to invest in the future of Alabama's municipalities for years to come so please take advantage of this program. Ken Smith and Greg Cochran of the League staff are available to answer your questions, so give them a call.

Another League program I want to call your attention to is the Alabama Municipal Insurance Corporation. As many of you know, AMIC has offered affordable, reliable insurance coverage to our municipalities for nearly 20 years – thanks to the foresight of League officials who created AMIC during a time when insurance was difficult for cities to come by. When Hurricane Katrina devastated the Gulf Coast – the insurance market became extremely chaotic. Some coastal areas have experienced up to an eighteen hundred percent - you heard me correctly, I said an EIGHTEEN HUNDRED PERCENT increase in insurance premiums; that is, if insurance is even available. AMIC, however, *has* not and *is* not pulling coverage from Alabama's coastal region and continues to provide a quality insurance product at a reasonable cost to its members. Be sure to contact this fine organization if your municipality has a question about liability or property insurance.

The League's Municipal Workers Compensation Fund, which is the second oldest insurance pool in the nation, recently celebrated its 30-year anniversary. More than 600 members strong, the Municipal Workers Comp Fund consistently gives a renewal credit to those members who had an average loss ratio of 75 percent or less, resulting in substantial savings for the Fund's members.

I would be remiss if I did not thank the members of the Lincoln City Council and all of the City staff. They have graciously allowed me serve you this year, and have always been behind me and our League. Again, I thank you for the privilege of serving as your League president. May God bless you and your communities.


Mayor Melvin Duran, Priceville, Elected League Vice President

AMIC/MWCF Safety Video Library

Any municipal official who has ever put together a safety meeting knows scheduling can be a daunting task. Regardless of city policy, some employees will not, for various work or non-work related reasons, be able to make these meetings.

To deal with this, supervisors must schedule several meetings or sessions so that all employees requiring the safety training can benefit from it, a process that uses up resources and becomes repetitive for whoever conducts the training. However, through a MWCF and AMIC program, training can be much easier than holding long sessions and demonstrations or having city employees read through safety manuals.

Since 1999, MWCF has maintained a safety video center, an in-house library with 356 titles on municipal issues. Within the library, municipal officials can find information on nearly any local concern that may arise, from animal control to proper lower back care and injury prevention for workers. A complete list of video titles is available on the AMIC website at **www.AMICentral.org** or by visiting **www.alalm.org** and clicking on the MWCF link.

Rachel Wagner, League research librarian and the program's coordinator, says having employees view videos in place of having them read through manuals or sit through demonstrations alone can be a great benefit to supervisors.

"It makes the information more accessible," Wagner said, "and meetings are a good place to show the videos and have high viewership."

Studies suggest that video learning helps employees learn as much as 55 percent faster and helps them remember up to 70 percent more information than oral instruction alone allows. Myra Forrest, MWCF/AMIC safety consultant, says member municipalities need to supplement safety training videos with other exercises to reinforce the information, using tactics like group discussions, practice demonstrations or even tests to drive the point home.

"Videos are an excellent means of communicating to employees a message or a skill," Forrest said, "[but] just sitting in front of the VCR for 10 to 15 minutes without reinforcement by management is not an effective learning environment."

Besides keeping city employees up to date on the safest ways of doing their jobs, video learning eliminates some of the repetition that goes along with training sessions. Instead of supervisors having to cover the same information in the same fashion over and over, the safety video library helps break up that monotony. An official may still have to hold more than one meeting, but being able to press a button and sit back and relax is easier than just lecturing for half an hour.

A number of Alabama's municipalities have taken advantage of this valuable and cost-free safety program, and

MWCF and AMIC would like more of their members to follow suit

MWCF and AMIC members can check out videos from the library in much the same way as they would from a mail order video rental service. Members put in a written request to the League for a maximum of three videos and, depending on availability, have them in hand in about four days. Members may keep videos checked out for two weeks before they have to mail them back.

If the League library doesn't have the video a municipality requests on hand, MWCF and AMIC members have another option. As a result of AMIC's sponsoring usage of the National Resource Safety Center's video library a few years ago, member cities can also access the more than 9000 titles the national center has in stock. Between this and the League's library, municipalities should be able to find safety information on any issue that may arise.

After 61 Years of Service, Faye Hosey Leaves City Hall

SYLACAUGA — She's known around City Hall as a "book of knowledge" and a "living archive." After 61 years of service to her city, Faye Hosey is retiring from the city clerk's office.

She has served 13 mayors since she began working at City Hall in 1945 and served as interim city clerk twice.

Mayor Sam Wright said Hosey has always treated the community of Sylacauga like family, along with everyone at City Hall.

"These 61 years of service to Sylacauga is her gift of love to the community. It is rare to have people spend 20 years on a job, but just think, she has spent 61 years providing a service to her community. That is truly unbelievable," he said.

Wright has worked with Hosey not only as mayor but as a councilman in the 1960s and as a businessman.

"Several years ago when I heard she was thinking of retiring, I told her she had a job with Wright-Sprayberry if she did retire. She is so dedicated," he said.

Wright said Hosey has looked after the city's finances as if they were her own.

"She will be missed. I am sure there will be times when we will call her for guidance," he said.

Once she is retired, Hosey hopes to find something to keep her busy and that is pleasing to God.

She calls the retirement reception (held in her honor on March 28) a "so long, been good to know you party. All I want is my friends to come – people I've worked with through the years, elected officials and others."

City clerk Patricia Carden has worked with Hosey the longest of any city employee. Former city clerk John Newberry hired Carden in July 1977. She has spent nearly 30 years working with Hosey.

"I learned over the years from Miss Hosey and Mr. Newberry. I've always said if you needed an answer, Miss Hosey could find it for you. She is a living archive. She can find something so easily, when it takes me a while. She has always helped customers so much. You can't replace someone like that with 61 years of city knowledge," Carden said.

Hosey said for a long time she and Newberry were the only two employees in the city clerk's office.

Hosey was born near Marble Valley in Coosa County. Her parents were Allen and Minne Deason Hosey.

She attended elementary school at Marble Valley and still remembers one of her early teachers, Esther Atkinson, who is now dead.

After graduating from Weogufka High School in 1942,

Hosey's first job was as a clerk at Woolworth's Five and Ten.

Later that year, she accepted a job with the office of Price Administrations Local Rationing Board as a clerk/ secretary.

It was the height of World War II, and Hosey turned down other, more attractive jobs to do her part in the war effort, according to a story about Hosey written by the late Bill Edwards in The Daily Home in September 1997.

When the war was over, Hosey went to work for the employment office in Sylacauga. She attended Perry Business College and Reynolds Business College, and with her background and experience, she soon became well known for her skills in city business circles.

She was approached by city officials about joining the city clerk's office. In December 1945, then city clerk Francis Pearson offered Hosey a job on his office staff.

Miles Motes was mayor at that time.

When Pearson left to become city clerk in Brewton in the late 1940s, C.J. Johnson was employed. He served until his death, and in 1967, John Newberry became city clerk.

He was succeeded by John Ham, who was followed by David Cohen, and then Carden.

Hosey served as interim city clerk in 1966 and again when Cohen left. She was appointed assistant city clerk in 1949.

Hosey remembers many duties she became associated with in her job. "You know, the clerk's office also handled all the functions before there was a separate Sylacauga Utilities Board.

"I did investments, kept books on all special accounts, worked with grants on the state and national levels and also worked at the counter with our customers. I learned my position by doing, along with the excellent assistance of Mr. Johnson and Mr. Newberry. Both were outstanding city officials."

Up until the last year or so, Hosey attended almost all of the City Council meetings and kept the minutes for many years.

Even during her six decades as an employee of the city, Hosey still found time to take part in other civic events.

She was a member and past secretary of the Sylacauga Beautification Council, served on the Board of Directors for the South Talladega County Chapter of the Salvation Army, served on the American Red Cross Board and the United Way.

She has also been a member of the Sylacauga Area Council on Arts and Humanities, Sylacauga Pilot Club and was a charter member of the Alabama Association of Municipal Clerks and Administrators.

In 1980, she was given the Distinguished Service Award by the Alabama League of Municipalities, and the late Mayor Joe Dark gave her a key to the city after 25 years of service with Sylacauga.

She was honored as the grand marshal for the Sylacauga Christmas Parade in 1995.

She received the "Achievement in Government Award" from the Sylacauga Business and Professional Women's Club during the 1975 observance of International Women's Year by the organization.

Hosey is active in First Baptist Church of Sylacauga, where she has served on a number of committees and served as president and assistant teacher for the Ruth Sunday School Class.

She jokingly said she is not sure how many years she has been a member of First Baptist Church. "Probably a 100 years," she said.

In addition to serving under Mayors Dark and Motes, Hosey worked with Ed Howard, Earl Atkinson, John Gann, Curtis Liles, Gene Stewart, Ross Payton, John Floyd, James Payton, Jesse Cleveland, Bruce Carr and now Wright.

Hosey's wish is that the city have continued success with its programs and improve through the years.

She said she will miss her association with city employees and officials. "It has been very pleasant, even though lots of times I didn't agree with them," she said. "I will continuously be interested in Sylacauga and its future."

Hosey said Sylacauga has been good to "me and I hope in my own small way I have been able to help the citizens of Sylacauga."

She said she never dreamed she would spend 61 years at one job.

She is hoping some of the former city officials come to see her March 28.

One tip she offered employees and officials as she prepares to leave her six decade post with the city, "If you don't know the answer to a question, ask someone. The Alabama League of Municipalities has always been a big help."

Hosey said her years with the city and its employees have been like "one big family."

Council President Doug Murphree has worked with Hosey 10 years. He is in his third term on the council.

"I hate to see her leave. She knows so much about everything. I have often sought answers from her. She will give you her opinion. She is so helpful. She is a book of knowledge. One thing is for sure, she knows how to keep the finances of the city in order. She has always been good at what I call 'rat holing' our money. She has done a lot for this city," Murphree said.
